## Time to Act

Nature is under extreme pressure, with the climate and biodiversity crises needing all of our attention in this critical decade. We need to act quickly, bringing much-needed resources to the table.

# Better Together

Nature Impact Collective (NIC) is a unique opportunity for funders who value working with like-minded people to leverage their giving.

By coming together, we make more informed and strategic decisions about how to support environmental NGOs. We harness significant funds to support eNGOs to work more sustainably and deliver better outcomes for nature.

We ensure more effective and efficient delivery of our grant programs by uniting the experience and expertise of our members and investing collectively in expert guidance and support.

As a collective, the decision on grantees is made in agreement between members and equal contributions are made towards each grant. The three inaugural members have committed \$500,000 per annum to this process, 10% of which is allocated to running costs.

We aim to highlight – through our collective vision, focus and strategy – how increasing resources to environmental causes results in positive change. Our goal is to inspire others to give as much as they can.

# **Grants for Nature**


We understand that the path to creating long-term protection and restoration of nature, is not linear, and requires flexibility and sustainable inputs.

We provide 'fit for purpose' funding that empowers organisations to deliver the impact we collectively aim to achieve.

NIC's grantmaking is guided by a shared strategy developed and owned by the members. This is informed by discussions with environmental leaders, scientists and practitioners, along with consideration of the AEGN Nature Funding Framework.

As part of our trust-based approach, the organisations we select are supported with core funding, and can choose to allocate funds over their preferred time frame.


Foundations and trusts may also wish to discuss becoming a member of NIC. Members commit to allocating \$500,000 annually over multiple years and participate in the collective giving process.

Nature Impact Collective's (NIC) first collective funding round selected five organisations championing the ecological health of Australia's inland waters. Each organisation will receive \$270,000, made up of three \$90,000 grants from NIC members. This funding is untied.

As the driest inhabited continent, Australia's fresh water systems are some of our most valuable natural resources, sustaining ecosystems and communities and holding deep cultural meaning for Indigenous people. Unfortunately, they have often been grossly mismanaged, and continue to face new threats.

The AEGN Nature Funding Framework identifies "Funding Waterways for People and Nature" as one of the top ten big gaps in nature funding.

The following organisations collectively lead change from the grassroots to Parliaments, protect intact ecosystems and restore damaged wetlands and waterways, engaging many communities including First Nations.

Country Needs People (CNP) supports Indigenous communities to manage land and sea Country. Their advocacy builds government funding and support for Indigenous ranger roles and the Indigenous Protected Area program. They work closely with around 50 Indigenous partner organisations.

## Environmental Justice Australia

Environmental Justice Australia (EJA) combines environmental legal expertise with strategic campaigns to protect the environment. With a long history of work on water and the Murray-Darling Basin, they are stepping up their focus on Ramsar-listed wetlands in the southern Basin.

# Murray Darling Conservation Alliance

A new alliance of state based organisations, the Murray Darling Conservation Alliance (MDCA) is ramping up a high profile campaign to restore the health of the Murray-Darling Basin. Heavily cleared, degraded and over-extracted while facing a hotter, drier climate, the future of the Basin rests upon an upcoming review of the Murray-Darling Basin Plan.

"This generous grant from NIC will enable us to mobilise community support in the lead-up to the next federal election and translate this into a political commitment to restore Australia's largest river system. Nature Glenelg Trust (NGT) started life in the cross-border area of South Australia and Victoria to increase on-ground environmental action in the region. Taking a holistic approach to biodiversity conservation, NGT has restored around 70 wetlands and established 10 of its own reserves.
